Draft Regional Solid Waste Management Plan

- ▶ NCTCOG is contractually obligated to update the Regional Solid Waste Management Plan (Regional Plan) and utilize the templates created by TCEQ to ensure consistency across all 24 COGs.
- ▶ The Regional Management Plan Subcommittee (RMPS) of the Resource Conservation Council (RCC) elected to update both Volume I and Volume II of the Regional Plan.
- ▶ The RMPS and NCTCOG also elected to hire a contractor through an RFP process to assist NCTCOG in updating the Regional Plan.
- ▶ Burns & McDonnell has completed the draft Regional Plan and it was reviewed and revised by the RMPS.
