1. Summary from last meeting

The meeting summary from the October 3, 2013 meeting was accepted as written.

2. Poster discussion

Three new versions of the IDDE training poster were presented. The only difference among the versions was the border color for the photos – black, red, and yellow. As a result of discussion after the meeting, all three poster versions will be available online.

3. FY 2014 projects

The FY 2014 projects were discussed and progress made on future planning. For Project 1, (The IDDE Task Force will collect detailed case studies on IDDE problem resolution and share information at IDDE meetings; selecting some for inclusion on a NCTCOG web page.) The cities of McKinney, Richardson, and Burleson committed to providing case studies for the next meeting on April 3, 2014. The City of Dallas committed for the July meeting.

For Project 2, (IDDE Task Force will become a clearing house for IDDE contacts for mutual information (including general contact information), NCTCOG will assist with posting information on web page as requested) members committed to sending their IDDE contact information to Jennifer Vuitel, at jvuitel@nctcog.org.

For Project 3, (IDDE Task Force will study the potential modification of existing materials or development of new to include more mention of bacteria. For example, training materials, field investigation guide, and the industrial inspector guide.), members decided to review the IDDE Field Investigation Guide at the April 3 meeting.

For Project 4, (The IDDE Task Force and NCTCOG will research and determine feasibility of a hotline and/or web reporting for IDDE), the inability to piggy back off of the Illegal Dumping Hotline was reiterated. There was considerable discussion regarding the possibility of an app and City of Richardson agreed to bring back some information on that city's own app at the next meeting. NCTCOG staff will present cost information for maintaining an online web page for IDDE reporting at the next meeting.

Lastly, the revolving project, the Industrial Inspector Workshop, was discussed. City of Dallas will make inquiries about providing a speaker. The cities of McKinney, Grand Prairie, and Fort Worth said they would look into facilities for the tour portion of the training, as did DFW Airport. The only change suggested to the workshop training materials was to include TMDL information. The tentative plan is to have the workshop by the end of March.
