He announced the Re-Trac Connect Municipal Management Survey was released on October 18, 2018 and the waste characterization study would begin the week of October 22, 2018. Scott also informed the RCC that the Materials Recovery Facilities (MRFs) interviews were almost all completed and that a January meeting will be held to share the information gathered.
