NCTCOG is continuing to coordinate OSSF trainings specific to homeowners, inspectors, and real estate agents. NCTCOG has tentatively scheduled a homeowner workshop for July 25 in Burleson that will include presentations from Ryan Gerlich, Texas A&M, and Becca GrassI-Petersen, Tarrant County, covering the basics of living with septic systems and the legal requirements for septic systems in Tarrant County.

The National Association of Wastewater Technicians is hosting a Septic Systems Inspectors Course on September 13 and 14, 2019 in Arlington. More information is available <u>online</u>.

The subcommittee discussed new projects, including the creation of educational materials for homeowners with OSSFs, including flyers, brochures, mailers, and other handouts. These educational materials will be directed towards homeowners, inspectors, and real estate agents.

NCTCOG presented the first edition of the new TMDL Annual Program Summary. The subcommittee suggested creating a Spanish Version and adding OSSF information.
