#### 1. **Welcome and Introductions.**

### **UPDATES AND DISCUSSIONS**

2. **FY22 Special Project Update.** NCTCOG will provide an update on the FY22 special project, a webinar or training on BMPs for the non-structural maintenance of waterways.

NCTCOG staff are looking into some of the non-structural stormwater BMP topics that were identified at the last Pollution Prevention Roundtable meeting. Currently, looking into disposal of pond dredging and street sweeping materials as there were specific comments from members requesting that topic. Staff is also exploring additional topics such as in-house pollution prevention education and responses to internal enforcement issues.

3. **FY22 Training Opportunities.** NCTCOG staff will solicit members' input on optional training opportunities for the current fiscal year.

NCTCOG staff proposed an alternative idea to the Mock Inspections and Site Tours for the current fiscal year training opportunity. The proposed training or webinar would be based on a simulated case study that was distributed in advance to a small panel of volunteers. The volunteers would have time to prepare a response to the case study in advance based on how their entity would likely respond. Time would be allocated at the end for a Q&A session between members and the volunteer panel. Staff will be working on drafting out a simulated case study in the coming months and will provide details as the training develops. 4. **FY23 Work Program.** Discuss whether to have a special project for FY23 and invite members to begin considering ideas to present at next meeting.

Staff sought input from members on the FY23 Work Program, specifically on a potential Special Project. A Special Project is not required as part of the group's change from a Task Force to a Roundtable, however one can be selected by the group. If one is selected, it would need to go on to the Regional Stormwater Management Coordinating Council for approval. For FY22, the group chose webinars/trainings as a Special Project and selected the topic of non-structural stormwater BMPs for the trainings. For clarification, that training is a separate task from the annual training that is part of the annual Work Program tasks. The group was asked to consider if they would like to include a Special Project for FY23 and what that project might look like. No consensus on a preference or ideas for a Special Project were expressed during the meeting. Staff plans to follow up with members on the FY23 Work Program, via email or survey, prior to the next meeting.

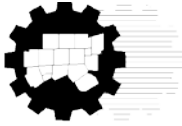
**Grand Prairie:** Working on SPCC updates and annual reports.
