
Purpose



Air Quality Update: Renewable Natural Gas Opportunities and Volkswagen Settlement Developments

Fleets using RNG in DFW

DART	DFW Airport
Uses 1.2 million MMBTUs of natural gas annually in CNG buses	Supports the McCommas Bluff LFG project
CNG fleet is expected to run on 100% RNG	RNG supplied will increase annually from 10% to 90% through 2025
Last month, DART approved a 5-year contract to utilize RNG in their CNG fleet	Since October 2017, DFW has received 30% RNG

Summary of RNG Vehicle Fuel Projects & Potential Projects

Operational Projects

12 projects in Texas, **5** of which are in DFW (3 at McCommas Bluff, and 2 at 121 Regional Disposal Facility)

LFG flow-to-project in DFW: **18.1 mmscfd**

Total yearly *methane* reductions for DFW projects: **3.88 MTCO2e**

Plus, **1 project** is under construction in Arlington LF


"Candidate" Facilities

54 Facilities in Texas are identified by the EPA (based on waste-load managed)

8 Facilities identified in DFW

Waste-in-place at "candidate" facilities within DFW: **42,004,748 tons**

Is there a need for more methane capture projects?


Are RNG projects feasible for private and public landfill owners?

TERP: Grant Programs

<u>Texas Natural Gas Vehicle Grant</u> <u>Program</u>

Eligible HD and MD motor vehicles can be *replaced* or *repowered*

Accepting applications until May 31, 2019

Texas Clean Fleet Program

Eligible applicants can *replace* HD and LD on-road diesel vehicles with alternative fuel and hybrid vehicles

Reimbursement up to 80% of the incremental cost


