NCTCOG will release the Avian Feeding Social Media Toolkit in the coming weeks.

<u>Feral Hog Management:</u> NCTCOG is hosting a Feral Hog Forum on August 13, 2019 at NCTCOG Offices. This forum will include presentations from Rachel Richter, Texas Parks & Wildlife, and Josh Helcel, Texas A&M AgriLife. More information is available at www.nctcog.org/envir/events.
