2. Greater Trinity River Bacteria TMDL I-Plan Wastewater Technical Subcommittee Meeting Summary. The November 30, 2017 meeting summary will be presented for approval.

#### DISCUSSION/PRESENTATION ITEMS

3. **Project Discussion:** NCTCOG staff will discuss activities pertaining to On Site Sewage Facility (OSSF) Inspector training (Task 5.2) and Sanitary Sewer Overflow Initiative (SSOI) data (Task 1.1).

The NCTCOG is currently preparing to conduct an On Site Sewage Facility (OSSF) workshop for real estate inspectors. The workshop will be instructed by William Merrell from the Houston-Galveston Area Council, and Rebecca GrassI-Petersen from Tarrant County. The course will be eight hours long and will include an assessment of a working OSSF. Six Continuing education credits will be offered through the Texas Real Estate Commission (TREC). The workshop will be held August 9, 2018.

The NCTCOG has updated the list of Sanitary Sewer Overflow Initiative and C-MOM program participant list for the Dallas-Fort Worth Area. The list is currently available in the I-Plan Status Report Draft, located <u>here</u>.

4. I-Plan Status Report: Review the content and recurrence of the I-Plan Status Report.

NCTCOG staff also discussed changing the frequency of the I-Plan Status Report from yearly to once every five years. The first Status Report was created in 2017 and covered the years 2013 through 2016. The 2018 Status Report covered FY 2017 work, during which minimal changes were observed. The NCTCOG staff requested the subcommittee's feedback on this suggestion. The subcommittee agreed that drafting the report on a five year basis is sufficient and that a short summary of program achievements is adequate on a yearly basis. The NCTCOG will request the approval from the Coordination Committee to change the I-Plan Status report to a five-year report.

NCTCOG requested that the subcommittee reassess the priority levels of the I-Plan implementation strategies. The subcommittee agreed to keep the status of implementation strategies 1.0, 1.1, 1.2, 1.3, 1.4, 1.6, 1.7, 5.0, 5.1, 5.2, 5.3, 5.4, and 5.5 the same. Implementation strategy 1.5 was changed from medium to high in priority due to the growing concern of aging infrastructure and the costs for repair and replacement.
