

# SUMMARY

Illicit Discharge Detection and Elimination Task Force Thursday, July 11, 2019 9:30 AM, Tejas Conference Room NCTCOG Offices, CPIII 600 Six Flags Drive, Arlington, TX 76011

1. Welcome and introductions.

The meeting began at 9:30 a.m. with introductions of all present.

### DISCUSSION/PRESENTATION/ACTION ITEMS

- 3. **FY 2019 Work Program.** NCTCOG staff will give updates or solicit input for FY 2019 work program items. (Mia Brown)
  - a. Basic Dry Weather Field Screening Training. NCTCOG staff will review the June Basic DWFS Training with the Task Force.

The Task Force discussed the Basic DWFS training held June 20<sup>th</sup>. The class was nearly full, and the evaluations were very positive. The Task Force agreed that future trainings would benefit from a more comprehensive testing experience and from a presentation about the report that communities file in conjunction with testing.

**b.** Advanced Dry Weather Field Screening Training. NCTCOG staff will discuss plans for the September Advanced DWFS Training with the Task Force.

The Advanced DWFS training will be held in September. A date will be selected soon pending room availability at the Carrollton library.

**c.** Automotive Related Business (ARB) Fliers. NCTCOG staff will present the third draft of the ARB fliers and solicit comments and/or seek a vote to approve.

The Task Force provided the last round of feedback, focusing primarily on improved pictures and consistency in formatting. NCTCOG will make the changes, have the documents translated into Spanish versions, and send both Publisher and Illustrator files to the members for use in their communities.

NCTCOG: The annual Combined CRS Users Group/Elected Officials Floodplain Seminar will be held July 18<sup>th</sup>. Registration is open on the NCTCOG website and attendance is good for three CECs for CFMs.

City of Southlake: Currently tracing a chlorine discharge.

City of Grapevine: Finalizing their SWMP and will submit it to TCEQ next week.

City of Carrollton: Currently finalizing their SWMP.

City of Dallas: Responding to water main breaks that are generating cloudy water complaints.

City of Bedford: Currently working on an MS4 permit.

City of Mansfield: Currently finalizing their SWMP. They are inquiring about other cities' post-construction requirements due to questions by their city council. The city was also audited recently by TCEQ on post construction.

City of Allen: The city just submitted their SWMP to TCEQ. They are also working on strengthening their post-construction ordinance.

City of McKinney: Currently working on post construction maintenance agreements and improving good housekeeping in their city work yard. They requested to tour other cities' work yards to see what works well.

City of Lewisville: The city recently traced a bright blue illicit discharge back to an HOA, located in another city, which used algicide with a dye in their ponds. The city stated that the use of robots made tracing this discharge much easier.

City of Fort Worth: Currently working on dry weather field screening.

City of Grand Prairie: The city just submitted their SWMP to TCEQ.

6. Schedule for the Next Meeting. The next meeting date is TBD pending format changes.


Mia Brown informed the Task Force that she would schedule a December meeting.
