

# SUMMARY

Illicit Discharge Detection and Elimination Task Force Thursday, December 12, 2019 9:30 AM, Six Flags Conference Room NCTCOG Offices, CPII 616 Six Flags Drive, Arlington, TX 76011

#### 1. Welcome and introductions.

The meeting began at 9:30 a.m. with introductions of all present. Mia Brown introduced Sydni Ligons as the NCTCOG staff member that will work with this group moving forward.

#### DISCUSSION/PRESENTATION/ACTION ITEMS

The summary was approved as presented.

- 3. **FY 2020 Training.** NCTCOG staff will give updates or solicit input for FY 2020 training events (Mia Brown)
  - a. Basic Dry Weather Field Screening Training. NCTCOG staff will solicit input for training dates, locations, and instructors.

The Task Force decided that a June training date would be best. The City of Carrollton agreed to host, and the City of Arlington agreed to lead the training.

**b.** Industrial Inspectors Workshop. NCTCOG staff will solicit input for training dates, locations, and instructors.

The Task Force agreed that pursuing Peterbilt Motors as the workshop location would be ideal. NCTCOG staff will reach out to Peterbilt to organize a date, preferably in spring, and will reach out to Task Force members should the location not be available. City of Arlington agreed to give the Phase 1 Community presentation. City of Carrollton tentatively agreed to give the Phase 2 Community presentation. City of Irving agreed to lead the mock inspection. NCTCOG staff will reach out to TCEQ for a speaker about the industrial inspection program and MSGP permit.

4. **Case Study Presentations.** The City of Fort Worth, City of Irving, and Dallas Area Rapid Transit will each present case studies to the group.

Dallas Area Rapid Transit (DART) and the City of Garland co-presented on tracing an oil sheen initially spotted in the DART right-of-way by track inspectors to a distribution center where City of Garland had conducted fire hydrant flushing.

City of Fort Worth presented on tracing a discharge with a low pH and high copper content to an industrial baking facility.

5. **Roundtable Topics.** The IDDE Task Force members and NCTCOG staff will share additional items as time allows.

City of Dallas has had multiple false reports of fish kills since the October tornadoes which have been primarily debris in ponds.

DART is completing their annual report, which has no major changes.

City of Garland is finalizing their annual report.

City of Frisco received a one-day audit from TCEQ a couple of months ago. While they are still waiting for the report with comments, the city said that TCEQ was mostly interested in their standard operating procedures, after action reports, notices of violation, citations, court proceedings, and stormwater management program plans.

City of Irving experienced a discharge over the weekend that resulted in no environmental impacts.

City of Plano is hiring for an environmental quality specialist.

City of Fort Worth is working on industrial inspections and wrapping up bioassessments and wet weather screening.

City of Bedford traced a black, foul smelling discharge to a trash compactor located directly over a storm drain at a grocery store. In October, the city experienced a kill of 1600 fish.

City of Mansfield is completing their annual report.

North Texas Toll Authority (NTTA) is completing their annual report.
