1. Summary from last meeting

The meeting summary from July 11, 2013 meeting was approved as written.

2. Poster discussion

The initial poster draft was presented and discussed. The poster is intended as reinforcement for city/agency staff who have viewed the new IDDE video. Requested changes included: a pumped up title, with a font that doesn't make capital L look like an I; more visible red X; brighter background for photos to help them stand out; better oily sheen photo; better suds photo, better hose photo if available and horizontal; and better leaking drum photo if available. The poster will be available online for entities to print on their own. Intended size is 11" x 17". Eight photos remain the agreed upon number on the poster.

Potential projects for FY 2015 were ranked and chosen by members present. The ideas presented (IDDE calendar, IDDE advanced training short course, Converting current IDDE video into video for the public (may involve working with Public Education Task Force), Spanish translation for current and adapted IDDE video, IDDE poster series, IDDE contact business cards, and Social media account) were discussed.

The IDDE poster series, a Spanish translation for the IDDE video, and establishment of a subcommittee to begin identifying/developing components of an IDDE advanced training short course, were selected as FY 2015 projects.

As a reminder, the FY 2014 projects are:

- 1) The IDDE Task Force will collect detailed case studies on IDDE problem resolution and share information at IDDE meetings; selecting some for inclusion on a NCTCOG web page;
- 2) IDDE Task Force will become a clearing house for IDDE contacts for mutual information (including general contact information), NCTCOG will assist with posting information on web page as requested;
- 3) IDDE Task Force will study the potential modification of existing materials or development of new to include more mention of bacteria. For example, training materials, field investigation guide, and the industrial inspector guide; and
- 4) The IDDE Task Force and NCTCOG will research and determine feasibility of a hotline and/or web reporting for IDDE.
