WS Works to Protect

- Human Health and Safety from wildlife-related diseases such as rabies and plague and wildlife-related hazards such as bird-aircraft strikes.
- Facilities, Structures, and Other Property from damage caused by rats, mice, raccoons, skunks, opossums, squirrels, beaver, birds and other wildlife.
- Crops, Timber, and Rangeland from damage caused by gophers, prairie dogs, feral hogs, raccoons, rabbits, coyotes, grackles, beaver and other wildlife.
- Livestock from depredation caused by coyotes, bobcats, feral hogs, mountain lions, raccoons, birds and other wildlife.
- Wildlife and Other Natural Resources such as endangered species and game animals as well as soil, water and flora from damage and predation by wildlife.

Vultures

- Black Vulture cause most problems
- Both Protected under Migratory Bird Treaty Act
- Chapter 64 of TPWD Code
- Depredation Permits available from US Fish and Wildlife
- No permit needed to Harass

Black Vulture

- Will attack and kill livestock and other animals
- Damage Buildings and Equipment

Depredation Permit Options

- USFW-Migratory Bird Depredation Permit
- Texas Wildlife Damage Management Association 5 bird permit.

Resident Canada Geese



- ◎ 5-14 lbs.
- ◎ 3 Years old for Sexual maturity
- ◎ Mate for life
- ◎ Nest March-April
- ◎ 2-9 eggs, avg. 5-6
- ◎ Incubation 28 days
- ◎ Molt lasts 20-40 days June-July

- ⦿ Molt migration
- ⦿ 3 lbs. of fecal deposits a day
- ⦿ Grass destruction
- ⦿ Disease concerns
- ⦿ Salmonella
- ⦿ E.coli
- ⦿ Giardia
- ⦿ HPAI

Harassment options

- ⦿ Lights
- ⦿ Coyote Decoy
- ⦿ Pyrotechnics
- ⦿ Dogs
- ⦿ Flagging





Options for control

- Migratory Bird Treaty Act
- TPWD chapter 64

- Register flock with USFW
- Oil eggs during nesting season

- Depredation Permit application
- Trap and relocate
- Lethal removal
