

Chapter IV Project Implementation/Progress from Previous Years

PROJECT LIST OVERVIEW

Section 450.326(n)(2) of Metropolitan Planning Rules requires that the Transportation Improvement Program (TIP) contain a list of major projects from the previous TIP that were implemented, as well as projects that experienced significant delays in their planned implementation. The Infrastructure Investment and Jobs Act (IIJA) emphasizes the TIP as a management tool for monitoring progress in implementation of the Metropolitan Transportation Plan (MTP). This chapter highlights the major projects implemented over the last three years, as well as projects delayed or cancelled during the same time frame. For purposes of this requirement, the Dallas-Fort Worth (DFW) Metropolitan Planning Organization (MPO) has defined major projects as those with construction funding over \$10 million. Projects were generally delayed due to funding constraints or project-specific issues such as right-of-way availability, utility relocation delays, environmental concerns, financial limitations, local government priorities, or design changes.

PROJECT IMPLEMENTATION

During the development of the 2025-2028 TIP, the Regional Transportation Council (RTC) made a strong commitment to implement projects that are listed in the TIP and the State Implementation Plan (SIP).

NCTCOG staff is actively monitoring progress to ensure that RTC-selected projects are being implemented in a timely manner.

One of the ways that the RTC has attempted to ensure that projects are advancing in a timely manner is through approval of the MPO Milestone Policy. Through two rounds of this initiative, staff identified projects that were funded in 2010 or earlier and had not proceeded to construction. New deadlines for projects to go to construction by were approved by the RTC. If construction does not begin by the agreed upon deadline, funding will be removed from the project and returned to the regional pool for use on other projects. Of the

57 projects identified on the initial Milestone Policy list that were funded in 2006 or earlier, all have



advanced to construction or were canceled at the request of the project sponsor. A second round of the MPO Milestone Policy initiative is underway for projects funded between 2006 and 2010 that have not proceeded to construction. Of the 41 projects identified in that round, 20 have advanced to construction, 13 have been canceled at the request of the project sponsor, and 8 will continue to be monitored.

In addition to the Milestone Policy, a project tracking initiative has been implemented by staff to monitor project implementation more closely. This initiative is intended to help identify potential issues that may delay projects earlier in the process to prevent them from causing delays of ten or more years. It also aims to reduce the amount of funds that carry over from one fiscal year to the next. The focus of this effort is on three RTC-selected funding categories: Congestion Mitigation and Air Quality Improvement Program, Surface Transportation Block Grant, and Transportation Alternatives Set-Aside. A list with all project phases funded with those sources that are anticipated to obligate in a given fiscal year is generated at the beginning of the year and periodic updates on the status of those projects are brought to the Surface Transportation Technical Committee and the RTC throughout the year.

The tables included in this chapter summarize the major projects for which construction or implementation has begun, is in process, or has been completed in the Dallas and Paris districts (Eastern Subregion) and Fort Worth district (Western Subregion) of the Texas Department of Transportation (TxDOT) from FY2022 to FY2024, as well as any delays from original project scheduling. It is important to note that the Federal Highway Administration implements federal projects through TxDOT, while the Federal Transit Administration (FTA) implements projects directly through designated recipients or grantees, identified as "implementing agencies" in the following tables.

The 2023-2026 TIP, as originally submitted, contained 385 projects. Over the course of the past two years, 183 projects were added through quarterly TIP modification cycles. Of these, 182 are classified as "major projects." Since the 2023-2026 TIP was initiated, construction started on 27 major projects. Engineering, environmental clearance, right-of-way acquisition, or utility relocation are underway for a significant number of these projects.

ROADWAY SECTION PROJECTS

The information provided for each project in these exhibits includes:

• original CSJ number (e.g., TxDOT project number)

- revised CSJ number (as appropriate)
- agency implementing the project
- TIP code (i.e., MPO project number)
- project location including project limits (i.e., from and to)
- project type
- original start date (date originally estimated for construction or implementation to be initiated)
- revised start date (if applicable)
- whether the project was let, completed, delayed, or cancelled since the last TIP was submitted, as applicable.

TRANSIT SECTION PROJECTS


Transit section projects are summarized differently than roadway section projects because the FTA implements projects in a different manner. Instead of "letting" like roadway section projects, once a transit project is included in an approved FTA grant for a particular fiscal year, it is incorporated into the relevant agency's operating budget and proceeds toward implementation. A list of projects included in FY2022 through FY2024 grant applications to date is provided in Exhibit IV-4 for the Fort Worth District and in Exhibit IV-5 for the Dallas District. Transit projects included in the Paris District are administered by TxDOT and can be found in the Statewide Transportation Improvement Program.
