The meeting summary was approved with no comments.

 2015 Sampling Activities Update. The North Central Texas Council of Governments (NCTCOG) staff, Atkins representatives, and the Dallas/Fort Worth representatives will update the Regional Stormwater Monitoring Task Force (RSMTF) on 2015 sampling activities.

Atkins updated the Task Force on the collection of samples during April. All samples have been collected as of April 17<sup>th</sup>. Equipment is functioning well, and there are no equipment purchases needed at this time. Fort Worth has not begun sampling yet, but may begin in June or July. Dallas has not yet finished sampling for the 2<sup>nd</sup> quarter.

4. **Next Permit Term Planning**. 2015 is the final year of sampling activities in the current permit term. NCTCOG staff will discuss the process and timeline for working with participants on a regional monitoring proposal for the next permit term.

Atkins staff gave a presentation about the previous monitoring terms and the monitoring program over time. The Task Force was asked to think about goals for the fourth permit term. The Task Force discussed the need for data comparisons before making any decisions on what should be studied during the next permit term. Best management practices documentation will need to be explored further if it is to be included as an objective on the next monitoring term. Discussions also included the addition of rapid bioassessments, dry weather monitoring, and if any EPA regulations will affect this program.



Members had the opportunity to share any community updates.


- 6. **Schedule for the Next RSMTF Meeting**. The next meeting is tentatively scheduled for Tuesday, July 28, 2015.
