Regional Stormwater Monitoring Task Force Thursday, November 23, 2013

1. Welcome and Introductions.

Jack Tidwell welcomed everyone to the Stormwater Monitoring Task Force Meeting.

DISCUSSION/PRESENTATION/ACTION ITEMS

2. **2013 Sampling Activities Update**. Staff, Atkins representatives, and Dallas and Fort Worth representatives will update the Regional Stormwater Monitoring Task Force (RSMTF) on 2013 sampling activities.

Atkins representatives informed the RSMTF that all 2013 data had been collected for Arlington, Garland, Irving, Mesquite, Plano, NTTA, and TxDOT.

Fort Worth had to re-sample one site, BFC3: and as soon as the report is received from the lab, their data will be complete.

Dallas has collected samples, and will send the data to NCTCOG staff to include in the report.

3. **2014 – 2015 Site Selection**. Staff and Atkins representatives will update the RSMTF on selection of sampling sites for 2014 and 2015 and seek RSMTF concurrence.

Atkins informed the RSMTF that sampling sites field visits were conducted in Garland, Plano, and for NTTA. Arlington and Irving have been contacted and site visits will occur soon. Mesquite and TxDOT do not require new sites for 2014 and 2015.

4. **2013 Annual Report**. The deadline for submission of the 2013 Annual Regional Monitoring Report to TCEQ is March 1, 2014. Staff will present a proposed timeline for development of the report and seek RSMTF approval of the schedule.

The RSMTF reviewed and approved the proposed schedule for the 2013 Annual Report.

5. **Modem Exchange**. Staff and Atkins representatives will update the RSMTF on the project to replace communications modems on sampling equipment. The old modems will be given to those RSMTF members that want the equipment returned.

Atkins was informed of RSMTF members that wished to have the equipment returned. Mesquite, TxDOT, and NTTA representatives took their modems with them after the meeting. Arlington, Garland, and Plano did not want their modems returned. Staff will contact Jeff Shiflet to determine if he has received Irving's modem from Freese and Nichols.
