1. Welcome and Introductions.

Members, meeting participants, and NCTCOG staff were introduced.

Presentations

2. **Overview of Sycamore Creek Bacteria TMDL.** Dr. Larry Hauck, Texas Institute for Applied Environmental Research (TIAER), will present the development and current status of the TMDL for Sycamore Creek AU 0806E_01.

Dr. Larry Hauck, TIAER, presented general information about TMDL and how it is applied, measured, and calculated using the Bacteria Load Duration Curve. Additionally, he presented specific information regarding the status of the TMDL for Sycamore Creek AU 0806E_01.

3. **Fort Worth Sycamore Creek Presentation.** Christina Osterlund, City of Fort Worth, will provide an update regarding the Sycamore Creek TMDL.

Christina Osterlund, City of Fort Worth, gave an overview of Fort Worth's efforts regarding the Sycamore Creek TMDL. The City of Fort Worth is currently sampling across the entire watershed to locate potential sources of pollution. The specified goal of the project is to restore Sycamore Creek water quality to bacteria levels that support designated aquatic use. They hope to complete sampling in winter or spring of 2019 in order to begin bacterial management strategies.

Action Items

4. **Greater Trinity River Bacteria TMDL I-Plan Coordination Committee Meeting Summary.** The June 15, 2017, meeting summary will be presented for approval. [The meeting summary is available online for review.](#)

NCTCOG provided an overview of the 2017 TMDL Coordination Committee summary and requested a motion for approval. Brigitte Gibson, City of Arlington, made a motion to approve and Jeff Shiflet, City of Irving, seconded the motion. The meeting summary was approved unanimously.

5. **Approval of the Second Annual Implementation Status Report.** NCTCOG will present the second annual Implementation Status Report, highlighting efforts pursued by TMDL area stakeholders, to the TMDL Coordination Committee for review and approval.

NCTCOG provided an overview of the second annual Implementation Status Report (Status Report) and requested a motion for approval. The committee also approved adjusting the timeline for updating the

Status Report. The Status Report will now be reviewed and updated every five years. On an annual basis NCTCOG will prepare a one to two page newsletter covering the highlights and achievements of the TMDL program for that year. Tad Heimburger, Dallas Area Rapid Transit, made a motion to approve the second annual Implementation Status Report and Jeff Shiflet, City of Irving, seconded the motion. The document was approved unanimously.

6. Resolution to Support Addition of Sycamore Creek Tributary Segment and Addendum 1 to I-Plan.

NCTCOG will present a resolution in support of the inclusion of the Sycamore Creek watershed into the Greater Trinity River Bacteria TMDL I-Plan to the TMDL Coordination Committee for adoption. NCTCOG will also present Addendum 1, which authorizes NCTCOG to administratively amend the I-Plan to include the Sycamore Creek impaired segment and complete associated technical updates.

NCTCOG provided an overview of updates made to the I-Plan, including revisions made to incorporate the Mountain Creek Lake Tributary segments, which were approved for inclusion at the June 2017 TMDL Coordination Committee meeting. NCTCOG also presented a resolution to support the addition of the Sycamore Creek Segment and Addendum 1 to the Greater Trinity River Implementation Plan. Rob McCormic, Dallas County Park Cities Municipal Utilities District, made a motion to approve the administrative updates to the I-Plan and the resolution in support of the addition of Sycamore Creek to the I-Plan, and Brigette Gibson, City of Arlington, seconded the motion. The motion was approved unanimously.

Discussion

7. FY2018 Accomplishments. NCTCOG will provide an overview of the accomplishments since the last TMDL Coordination Committee meeting in June 2017.

NCTCOG presented the accomplishments achieved during FY2018. Accomplishments included:

- Developed and distributed a TMDL Annual Questionnaire to TMDL stakeholders regarding I-Plan efforts,
- Planned and promoted the North Texas Feral Hog Conference, and
- Facilitated the Texas Stream Team (TST) workshop.

8. FY2019 TMDL Technical Subcommittee and Coordination Committee Activities. NCTCOG will share proposed FY2019 activities with the Coordination Committee.

Upcoming TMDL projects for FY2018/2019 include: Texas Stream Team – Train-the-Trainer (July 25, 2018), On Site Sewage Facility Workshop for Real Estate Inspectors (August 9, 2018), Feral Hog Sighting Database (Beta in FY2019), and Riparian Bull’s-Eye Evaluation Workshop (FY2019).

a. Technical Subcommittee meeting schedule

NCTCOG suggested changing the Technical Subcommittee meeting schedules from bi-annual to as-needed; the Coordination Committee agreed to this change as it will provide the opportunity to meet more regularly when project implementation activities are underway.

NCTCOG also provided an overview of the projects chosen by the Technical Subcommittees to be pursued during FY2019. These include:

- **Wastewater Technical Subcommittee:** OSSF inspector training; outreach for inspectors, real estate agents, and homeowners.
- **Stormwater Technical Subcommittee:** Continue urban feral hog management; development of education and outreach materials to address avian feeding and pet waste.
- **Monitoring Coordination Forum:** analysis of TMDL water quality data to determine the effect of the current implementation efforts.

9. **Staff Updates and Roundtable Discussion.** Members and staff share what is happening in their communities.

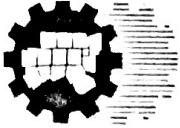
- **NCTCOG:** Bioassessments underway in Plano, Garland, and Irving. DOO the Right Thing calendar contest submissions ends on June 30. The City of Irving certified Silver for iSWM program. Upcoming trainings: IDDE Basic Dry Weather Flooding Training (June 2018) and Grease Trap Training (October 2018).
- **DART:** Suggested providing public comments on the TCEQ update to small MS4 permits to make the language more understandable.
- **City of Bedford:** The City of Bedford will have a new operations manager at the next meeting.
- **City of Edgecliff Village:** Working on MS4 permit renewal.
- **Trinity River Authority:** Working on the Village Creek-Lake Arlington sediment and E. coli project for the Watershed Protection Plan. Aquatic life monitoring starting at three sites.
- **City of Arlington:** The City of Arlington has a Stormwater Assistant Director position available. A PE license is required.
- **City of Fort Worth:** MS4 permit received and continuing efforts to locate pollution sources. Additionally, a conceptualized Wastewater Treatment Plant in Mary's Creek is in progress.
- **City of Plano:** The Stormwater Division renamed to the Environmental Quality Division.
- **City of Dallas:** Examining watershed land use to determine sources of pollution.
