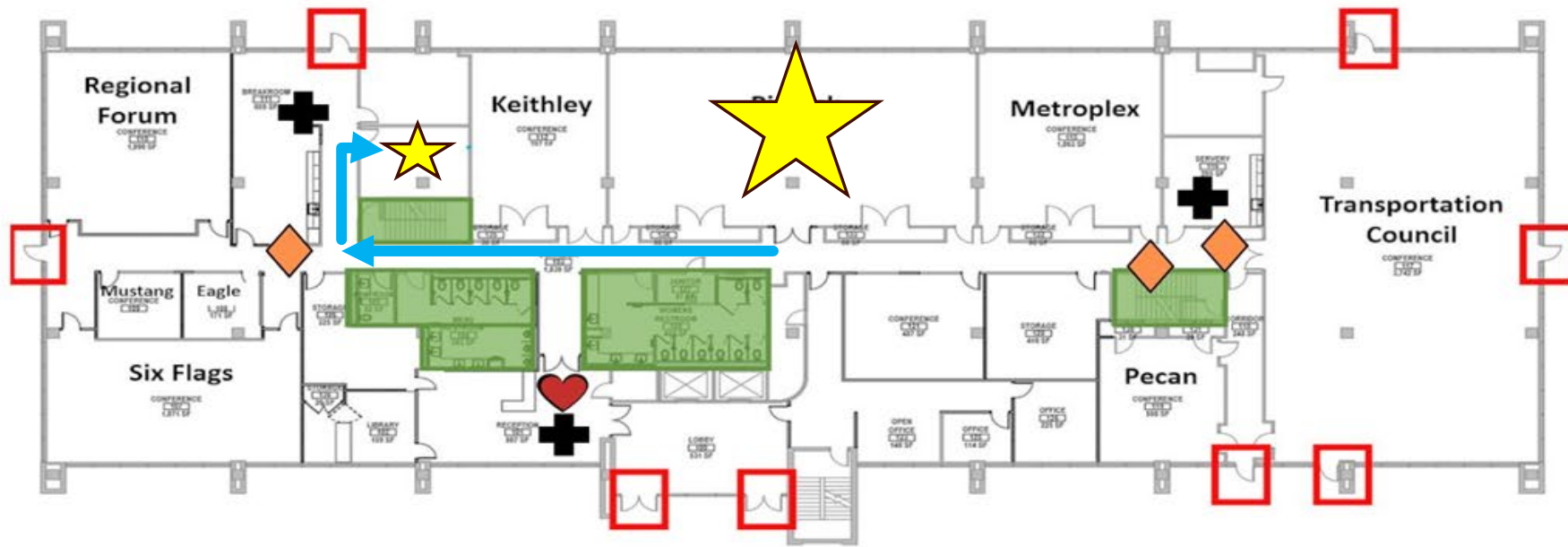

LEGEND

- Severe Weather Sheltering Areas
- Building Exit
- Fire Extinguisher
- Stop The Bleed Pack
- AED
- Evac Chair *On floors 2, 3, 4 by restrooms*

FIRE EVACUATION

1. Locate nearest exit, circled in green, using map above
2. Assuming the exit is safe, quickly exit the building and head towards dept. rally point
 - DO NOT USE ELEVATORS
3. If exit is not safe, find the next nearest exit to use
4. Notify your supervisor of your safe location

SEVERE WEATHER

1. Locate nearest Severe Weather Shelter Area on the map
2. Exit the room quickly and take shelter in the nearest marked location
3. Notify your supervisor of your safe location

ACTIVE THREAT

RUN

- Evacuate if there is an accessible escape path
- Evacuate regardless of whether others agree to follow
- Leave your belongings behind

HIDE

- Hide if evacuation is not possible
- If you are in an office, stay there & secure the door
- If you are in a hallway, get into a room & secure the door

FIGHT

- As a LAST resort, attempt to take the active shooter down
- Throw items & improvise weapons
- Yell

- **SB 725**: Relating to the regulation of used automotive parts recycling, including the removal of license plates and registration insignia.
- **HB 1904**: Relating to the release of a balloon and associated littering; creating a criminal offense.
- **HB 1730**: Mandates a study by the University of Houston on the health effects of perfluoroalkyl and polyfluoroalkyl chemicals in food, water, and equipment.
- **HB 2048**: Relating to an incentive program to promote beverage container recycling.
