

- Tarrant Regional Water District
 - Tarrant Regional Water District kicked off their Eagle Mountain WPP Stakeholder meeting in January and plans to have the final document ready for agency review in December 2025. TRWD is working in the Richland Chambers Watershed on a monitoring model with TWRI and expects it to be shared in Fall 2025. They are working to receiving funding for Agriculture BMPs in the Bridgeport area as well. Further, TRWD hosted Duke University Masters' students in which they studied mitigation value and watershed protection value for green space preservation, including intangible factors such as ability and willingness for that preservation.
- Texas A&M AgriLife
 - Texas A&M AgriLife did not have any updates.
- Trinity River Authority:
 - The Trinity River Authority is working on Clean River Program activities and wrapped up the first year of implementation on a cage mussel study, which will also include long term monitoring. They also launched a snapping turtle tracking/siting tool online at trinityra.org/turtles.
- Upper Trinity Regional Water District
 - The Upper Trinity Regional Water District is working on monitoring Lake Lewisville and is doing a study on the overall impacts of lake development, new lake construction, lake/water quality protection, and more.
