# Deadlines for Modification to the Dallas-Fort Worth Transportation Improvement Program (TIP)/Statewide Transportation Improvement Program (STIP) February 2025 – May 2026 Cycles

The following deadlines have been established for projects requiring modifications to either the Dallas-Fort Worth Area TIP or the STIP. Please note it takes approximately six months to receive approval for TIP actions that require a change to the STIP. If you anticipate TIP action on projects within your area, below are the deadlines that should be built into your project timelines. To ensure timely action, please coordinate with the TIP Team early in the process.
