 - Provides Gas Simulations Training
 - Hosts multiple dispatch centers
 - Oversee (8) states operations to gas customers
 - Works with TDEM winter weather operation calls. Mobile command & Gas city.

 - David Bonnette, Science & Operations Forecaster
 - **Discussion Points:**
 - ENSO (El Nino Southern Oscillation) Phase
 - Ocean Sea Surface Temperature Influence
 - Is there any truth to stronger than normal cold temperatures 2024?
Perspective from 2021 Ice Storm, we will see arctic air but will not experience 2021 impact
 - The tornado in 2015 was it during La Nina or La Nino? Unsure, but typically Warm Front in cold temperatures will lead to tornadoes
 - Ice Storm Warning Vs. Winter Storm: Ice storm is perceived more important. NWS messaging will be emphasized on Ice Storm as more critical.
- **World Cup Region Public Safety - Arlington Updates: PowerPoint Not Attached**
 - Irish Hancock, EM Administrator – City of Arlington
 - (9) Matches between June 14th-July 14th, 2026, most games hosted for an area in 2026, Matches will not be back-to-back.
 - **FWC26 Venues:** Base Camp is where the teams will be staying at, IPC will be the World's International Media site, Kay Bailey will be operating multiple functions for the FIFA World Cup, Kay Bailey is expected to be under construction during FIFA World Cup
 - **SEAR Ratings:** Games #1- #8 is SEAR 2, Game #9 is SEAR 1 as it is a semifinal. Games #1- #8 may change based on teams that play.

- **Independence Day Concern – 2026:**

 - Jurisdictions will have to communicate with City Planning based on July 3rd celebrations. World match is intended to be played on July 3rd, 2026 and unsure if that will be a day or night game.
