The North Central Texas Council of Governments (NCTCOG) is initiating the Dallas to Fort Worth High-Speed Transportation Connections Study (DFW HST Connections Study) in cooperation with the Federal Railroad Administration and the Federal Transit Administration. The study will be conducted jointly by NCTCOG staff and our consultant, HNTB. The DFW HST Connections Study will examine high-speed transportation technologies and corridors connecting downtown Dallas and downtown Fort Worth. A draft map identifying the project study area is attached.


