1. Welcome and introductions. NCTCOG staff and meeting participants will be introduced.

Members of the Water Resources Council (WRC), meeting participants, and NCTCOG staff were introduced.

Action Items

2. Meeting Summary. The January 19, 2017 meeting summary will be presented for approval.

The meeting summary was unanimously approved by the WRC.

Discussion

3. North Central Texas Water Resources Questionnaire Results. NCTCOG will discuss the North Central Texas Water Resources Questionnaire results and provide an overview of the development of the draft report.

NCTCOG presented the North Central Texas Water Resources questionnaire results to the WRC. Ron McCuller, City of Grand Prairie, posed a question about the status of water conservation in the North Texas region. He discussed the City of Grand Prairie's successes with the AMI water metering and implementation of the water conservation plan and suggested that NCTCOG seek information about per capita water use in the NCTCOG region as an indicator for water conservation efforts. Stacy Walters, City of Fort Worth, mentioned how the City of Fort Worth is working to rebrand water conservation to water efficiency, to encourage people to use water wisely, instead of not at all. NCTCOG will research information about current and historical per capita water use information for the North Texas region and incorporate it into the WQMP.

Edith Marvin, NCTCOG, asked the WRC if entities were experiencing challenges associated with flushing water because of water conservation efforts and suggested engaging in a study to see the impact of water conservation on the utilities. The WRC indicated that the percent of water loss due to flushing was minor in the grand scheme of water purchased and using resources on a study would not be beneficial. The WRC suggested investing in education and outreach about the perception of operational water use, such as flushing the pipes.

4. **2017 Water Quality Management Plan (WQMP) Update.** NCTCOG will provide the discharge monitoring report data to the committee for review and go over other information that will be added or updated as a part of the 2017 WQMP Update.

NCTCOG presented the Discharge Monitoring Report (DMR) data for calendar year 2016 to the WRC. Glenn Clingenpeel, Trinity River Authority (TRA), requested that the TRA wastewater treatment plants (WWTPs) be labeled as operated by TRA in the permitted facility column. Jason

NCTCOG will take actions to include the appropriate updates to the DMR data. Members of the WRC also requested a footnote describing the skewed data from calendar year 2016 due to high flows from rainfall in 2016. NCTCOG will incorporate the requests into the final document.

5. **FY2018 Water Resources Council Committee Reappointments.** NCTCOG will be sending out reappointment forms for FY2018 in May and plans to bring the completed roster to the committee for approval at the June 8, 2017 meeting.

NCTCOG will be sending out WRC reappointment forms for FY2018. Forms will be made available to the appropriate members in May.

6. **Topics for next workshop.** NCTCOG is seeking feedback on potential topics of interest for the next workshop to be held before August 31, 2017.

NCTCOG presented potential topics for the next workshop to be held by NCTCOG. Ron McCuller, City of Grand Prairie, suggested looking at water scalping and reuse as potential topics. Other members of WRC encouraged NCTCOG to pursue a water reuse topic for the workshop. NCTCOG will work with members of the WRC to gain guidance on specific topics related to water reuse that would be relevant to the North Texas region.

Other Business and Roundtable Discussion

7. Roundtable. Members and staff share what is happening in their communities.

NCTCOG provided an update to the WRC regarding the following items:


