Committee Members

- February 2024
 - Did not make quorum to vote. Tabled until August 2024, REPAC meeting.

Business Items

o - Did not make quorum to vote. Tabled until August 2024, REPAC meeting.

Discussion Items

- 2024 SHSP Projects Update
 - Congress passed a budget, however, they cut a lot of our budget.
 - We will have a few cuts for our projects and the state will take a big cut of it. They went from \$18.2 million in 2023 to \$16.3 million and just 2024 grant. This is about a \$2 million cut.
 - We changed the way we do our allocations for the regional priority areas. We've always had different percentages we had to meet for different priorities areas. The only one that has a percentage attached to it now is Election Security. We can now choose which priorities it should go to.
 - Priority areas include Intel & Information Sharing, Combating DVE, Community Preparedness, Cyber, Election Security, and Soft Targets.
 - 3% of the funding had to go to Election Security.
 - 30% of our funding had to be allocated to our priority areas. This will help us with 2025 planning.
 - NCTCOG proposed allocation was \$1.5 million. We received \$1,372,500.
 - 2024 NCTCOG SHSP Projects that were funded:
 - Regional Planning, Metro X, Metro X (LETPA), PWERT Interdiction Trailer, SWAT Comms Project –
 Mesquite, SWAT Comms Project Hurst, and EOD Slash and Go Training. These were all fully
 funded. SWAT Comms Project Irving was partially funded. There were some priorities that will not
 be funded.
 - Public Education Enhancement (KnoWhat2Do) that did not get funded, will be funded by the Regional Planning project for 2024.
 - o Funding was lowered due to lack of ranking and congress.
 - It would be beneficial to strategically figure out a process on how to hold cities accountable for their insufficient ranking, however, we must be careful on how we hold jurisdictions accountable. We will need to figure out a process.
 - Competitive Projects:
 - o Wise County DVE \$15,000
 - Multiple entities working to restore funding to 2023 levels. We are planning for the same original funding level for the region that we did for 2024 in 2025. Therefore, we will need more projects. Will need to meet 30% regional priority areas in 2025
 - Election Security will be competitive statewide
 - OOG will not submit Cybersecurity IJ for SHSP
 - We will not receive state swept funds. Swept funds will go to smaller COGs and state agencies. The funding that we receive, we must spend it. If we don't spend it, we will lose it.
 - o Justin Cox will need to be notified if your jurisdiction is having issues with your projects.
- REPAC Nominations

- The next 3 working group seats to be approved at the August meeting is EGRT, Pub ED, and CCP

REPAC Vice Chair

- It is a 4-Year commitment. 2-years as Vice-Chair, and 2-years as Chair.
- Nominations will need to come from a jurisdiction within one of the 4 Urban Counties, (Collin, Dallas, Denton, and Tarrant)
- Voting will take place at the August meeting.
- We encourage you to nominate someone or yourself for REPAC Vice-Chair.

Grant Dashboard & Project Update

- EMWG Grand Prairie Project is making progress; trailers are due very soon.
- Interop Phases II of the Regional Interoperable Communications Plan, more funding will be spent as we move forward.
- CCP Working with leadership to identify and order burn pans
- PubEd Maintenance to the KnWhat2Do website is complete. Supplies for TDEM conference was requested and ordered.
- T&E waiting on invoices from vendors for upcoming exercises. A 1-month extension was requested for T&E due to RFP process.
- USAR Working Group has identified the USAR trainings. Tarrant County College and Collin County College are working out a deal with the group to get in as much training as possible.
- Fusion Analyst position, working on DVE projects.
- EOD Denton (completed project), Mesquite, and Irving expenses have not been reported yet. Fort Worth received funding for training no expenses reported
- SWAT Frisco no expenses reported, Plano no expenses reported, Mesquite no expenses reported, Prosper have completed their project and closed it out.
- Hazmat City of Dallas no expenses reported, City of Fort Worth no expenses reported, Wylie completed their project, and de-obligated funds. (Be sure to let Justin know before de-obligating funds.)

Cyber/EOC/Fusion Workshop & TTX Update

- Workshop planning meeting is May 16, 2024, 1:00 pm. Will have best practices for Cyber/EOC/Fusion from entities that have had attacks.
- Want to bridge the gap between cyber incidents.
- Critical Infrastructure
- TTX will take place in October/November 2024. There will be 3 virtual table-tops based on Fusion area of responsibility.
- Chance for EOC's to invite staff and run through a cyber scenario.
- Potential build up to Metro X.
- The initial planning meeting is June 12th.

Metro X Update

- We will be fully funded for our Metro X exercise.
- 2024 SHSP project to help out region prepare for major regional special events. It will be similar concepts and scenarios as in the 2011 Super Bowl.
- Full scale, multi-discipline exercise consisting of a CCTA scenario
- We have submitted an application to FEMA National Exercise Program. We should hear back from them in June.

- o August 2024: RFP Submitted
- o October 2024: Initial Planning Meeting
- o Oct-Nov 2025: Metro X
- Planning team consisting of EM's, reps from working group, and state & federal partners.
- 3-day exercise (8-10 hours each day)
- Objectives discussed:

- o Multi-discipline/agency integration
- Area command communications
- o Regional Support Center/DDEOC we will be exercising this scenario.
- o Patient Tracking we have a new system in place.
- Short-term recovery
- o CRBNE scenarios
- Potential Locations:
 - Six Flags/ATT Stadium/Choctaw Stadium
 - Carrollton Sports Complex
 - o Collin College
 - Lone Star Park
 - o Churches/schools
 - Plano Fire Training
 - Outlying Counties
- Not all working groups will play each day.
