

Scope of Work & Study Area


The selected consultant(s) will provide the services listed in the Scope of Work as needed to all areas of the 16-county NCTCOG region.

Eligibility for station locations is restricted to public property only.

At least 50% of project sites must serve Justice 40 communities.

The primary goal is to fill charging gaps in the region and provide charging access to underserved areas.
