Meeting Purpose	Coordinate with cities and other interested parties on the coordination of land use and transportation planning in North Texas. The purpose of this meeting was to provide a general overview of NCTCOG Land Use/Transportation efforts and begin discussions for the Task Force going forward.				

#### Discussion Items

Welcome and introductions by NCTCOG staff.

#### 1. Introduction to Coordinating Land Use and Transportation and NCTCOG Resources

NCTCOG staff briefly discussed the connection between transportation and land use and the significant need to coordinate their development together to achieve public benefits in both areas. NCTCOG's long-range regional transportation plan, Mobility 2045, emphasizes coordination with land use as it will take strategies beyond just new construction to address regional transportation challenges. Goals of this task force include reducing silos between land use and transportation professionals, sharing best practices, and providing a place of learning and knowledge for the region.

### 2. Steps to Success: Cases of Coordinated Land Use and Transportation in North Texas

NCTCOG staff members provided the group with an overview of past and ongoing NCTCOG programs and initiatives focused on coordinating land use and transportation. These include the Sustainable Development Funding Program infrastructure projects, transit-oriented development projects, school site and access planning, private sector/commercial real estate coordination, corridor planning projects, the WalkUP Wake-Up DFW Report, Blue-Green-Grey grant, and various other efforts advising local land development policies integrated with a transportation focus.

### 3. Economic Value of Walkable Urban Development

Michael Kovacs, City Manager for the City of Fate, presented on Walkable Urban Place (WalkUP) Economics and growth patterns in the region and within the growing community of Fate, Texas. He discussed the importance of balancing growth and infrastructure costs, such as which development types generate more return on investment to improve city revenues and how the City of Fate is implementing this concept. Currently Fate is revitalizing its downtown through a new trailhead and redevelopment project that will include various mixed-used buildings, new restaurants, shared workspaces, and a brewpub intended to attract visitors and improve tax revenue and walkability.

### 4. Value of Form-Based Code

Laura Voltmann, Senior Planner at the City of Fort Worth, discussed how form-based codes create a predictable public realm through more guidance and regulation of the built form and less on land use restrictions. The City of Fort Worth has been creating design-based districts for over a decade, with one of their first covering the Near

Southside neighborhood. For this neighborhood, Fort Worth revised their street standards to a more urban context and required streetscape enhancements. The City has also promoted development in these zones with coordinated infrastructure upgrades following the code's design principles. Other form-based codes discussed included Panther Island and Trinity Lakes. Form-based codes in Fort Worth use standards for urban streetscapes, street design standards, and regulating plans which guide the street geometry to achieve connectivity and access with a pedestrian-friendly urban form.

Questions asked following the presentation included:

What public engagement processes are used to create these districts?

A community charrette-based process like that which the city used to create the Berry/University form-based code around TCU are the preferred way to engage on detailed design topics and work through local issues.

## 5. Discussion and Live Poll – Top Issues in North Texas Coordinating Land Use and Transportation

NCTCOG staff presented the task force with possible future meeting topics that included site design and building form, street grids and re-establishing existing grids, dealing with density, finance in land use and transportation planning, and other topics. A survey was sent in the Teams chat for meeting participants to take during the meeting. Participants were also able to enter comments in the chat area and NCTCOG also sent a survey link to participants following the meeting.

NCTCOG staff also informed the group about the community gardens survey that was recently sent to meeting participants to develop a regional inventory of community gardens, which will aid NCTCOG's creation of a guide for development of community gardens programs in the region.
