

### **DEBRIS MANAGEMENT PLAN**


- Activated our Debris Management Plan with key components to assist in the response effort

- Debris haulers arrived in Richardson on Friday May 31,2024
- City Staff and Debris Contractor developed a strategy to begin collecting vegetative debris on Monday June 3, 2024








