- Task 5 – Research Cumulative Impacts on Small Footprint Developments
    - o Will utilize XPSWMM models of Linwood area developed as part of City of Fort Worth’s cumulative Impacts Study in 2022
    - o Focusing on typical block or neighborhood, evaluate impervious scenarios and subsequent impacts on hydrology and hydraulics
