The United States Environmental Protection Agency (EPA) has reviewed conformity determination documents for the 2022 update of the *Mobility 2045 Metropolitan Transportation Plan (MTP)* and the *2023-2026 Transportation Improvement Program (TIP)*, submitted by the North Central Texas Council of Governments (NCTCOG) for interagency consultation and review. A conformity determination is necessary for the Dallas/Fort Worth, Texas (DFW) 8-hour ozone NAAQS nonattainment area due to the update, and the need to comply with the Infrastructure Investment and Jobs Act signed into law on November 15, 2021.

Any issues associated with the demonstration of conformity were addressed in conference calls and e-mails with the NCTCOG, the Federal Highway Administration (FHWA) Texas Division office, the Texas Department of Transportation, the Texas Commission on Environmental Quality, and the EPA. The criteria for our review and the interagency consultation process can be found at 40 CFR Part 93, Subpart A and guidance memoranda issued by the FHWA and the EPA for transportation conformity determinations.

Based on the information submitted to the EPA and discussed during the interagency consultation process, the estimated emissions of nitrogen oxides (NO_x) and volatile organic compounds (VOC) for the updated Mobility 2045 MTP and 2023-2026 TIP will be below the motor vehicle emissions budgets (MVEBs) established for these pollutants in the State Implementation Plan: The 2017 NO_x and VOC MVEBs became effective on November 23, 2016 (81 FR 78591). We have no further comments and are supportive of a positive conformity finding by the FHWA for the DFW area.
