# Trinity River COMMON VISION and Corridor Development Certificate Program





1989 interlocal agreement included 10 cities and 4 counties

1990 feasibility study on cumulative impacts of development

1990 Flood Management Task Force – meets quarterly

37% of active flood storage in region's Trinity River corridor located in Corridor Development Certificate regulatory area

> 200 projects reviewed by regulatory process that allows floodplain development that does not raise flood water levels or reduce flood storage capacity







# Community Rating System Users Group

FEMA voluntary incentive program

Communities adopt practices that exceed the minimum requirements of the National Flood Insurance Program

Property owners receive discounts on flood insurance

North Central Texas group meets quarterly



<sup>\*\*</sup> Preferred Risk Policies are available only in B, C, and X Zones for properties that are shown to have a minimal risk of flood damage. The Preferred Risk Policy does not receive premium rate credits under the CRS because it already has a lower premium than other policies. Although they are in SFHAs, Zones AR and A99 are limited to a 5% discount. Premium reductions are subject to change.




# Regional Public Works Program



integrated Stormwater Management program provides guidance and technical support for communities to adopt practices to protect water quality and streambanks and to mitigate flooding





Public Works Construction Standards provide specifications and standard drawings for infrastructure, including stormwater drainage

Sustainable Public Rights of Way efforts promote best practices to improve air and water quality, improve infrastructure life cycle and performance, promote economic development, promote integration of rights of way and surrounding land use









# TXShare OneRain Regional Flood Warning Software Program


Provides hydrologic and flood warning software from Contrail

Communities can set predefined alerts

Visualize gauge readings to better prepare for storms

Allows any community to join regardless of system size

Flexible tiers including ancillary services







# Regional Stormwater Management Program



Regional Stormwater Management Coordinating Council guides regional approach to stormwater management including assisting with Stormwater Management Plans and providing educational resources

Public Education Task Force promotes municipal stormwater public education programs including Doo the Right Thing, Texas SmartScape, North Texas Community Cleanup Challenge, and Yard Waste

Pollution prevention (P2) resources help communities prevent or reduce pollutant runoff from municipal operations, remove floatables and other pollutants discharged from storm sewers, and develop procedures for proper disposal of wastes







# Water Quality Management Program


NCTCOG is the regional water quality planning agency for

North Central Texas

Water Resources Council is a regional forum for water resource issues

Together they produce the region's Water Quality Management Plan:

- Identifies effective water quality programs
- Identifies issues that impact water quality, wastewater treatment strategies, and water supply
- Provides updated data
- Maps permitted on-site sewage facilities (septic systems)










# Economic & Environmental Benefits of Stewardship Tool (EEBS)


# 16 County Watershed Management Initiative

Roundtable met in 2017

Surveyed county floodplain managers on current practices

Discussed Texas Water Code § 16.315. authorizing counties to engage in floodplain management:

- Adopting and enforcing permanent land use and control measures
- Declaring property to be in violation of local laws, regulations, or ordinances
- Taking steps, using regional, watershed, and multi-objective approaches, to improve management and use of floodprone areas
- Adopting more comprehensive floodplain management rules
