Refrigerant Piping Shaft Requirements Opinion Statement

The Opinion Statement for A2L Refrigerant Piping Requirements was developed by Jordan & Skala Engineers with input from Building & Residential Advisory Board.

This opinion statement covers how to safely use A2L refrigerants for HVAC and Refrigeration systems in buildings for different building code and mechanical code years, including different version of ASHRAE Standard 15.
