

# Environmental Checklist

## 2022 Transportation Alternatives Set-Aside Call for Projects For the North Central Texas Region

This form is not a substitute for a project level environmental analysis, but to determine those environmental issues that may greatly impact your project and its schedule. ### **A. PARK LANDS**
