Legislative Update May 29, 2025

FROM WASHINGTON, D.C.

Congress is on break for the Memorial Day holiday and returns June 3, 2025.

FROM AUSTIN

The last day of the 89th Texas Legislature (sine die) is four days away. The Legislative Budget Board (LBB) posted the Budget Conference Committee's decisions. The House and the Senate each approved their own draft budgets and had been working out their differences in a conference committee over the past month; the recommendations are now posted online. The final budget has not been voted on by the full House and Senate at this time. The final day to adopt conference committee reports is June 1. A final list of approved bills and final budget information will be provided next week.

HIGHLIGHTED BILLS WITH ACTION

- SB 1036, Relating to the regulation of residential solar retail transactions. Passed the House on May 23, 2025. Enrolled and forwarded to the governor for action.
- SB 1902, Relating to the administration of the dealer-issued license plates database and to the removal and transfer of license plates. Passed the House on May 23, 2025. Enrolled and forwarded to the governor for action.
- SB 2129, Relating to the operation of vehicles at railroad grade crossings. Passed the House on May 23, 2025. Enrolled and forwarded to the governor for action.
- SB 2569, Relating to the reporting requirement for certain law enforcement agencies regarding the agencies' use or operation of an unmanned aircraft. Passed the House on May 23, 2025. Enrolled and forwarded to the governor for action.
- HB 2440, Relating to the authority of a state agency or the state's air quality state implementation plan to impose certain restrictions with respect to a motor vehicle, including a motor vehicle powered by an internal combustion engine. Passed the Senate on May 23, 2025. Enrolled and forwarded to the governor for action.
- SB 1555, Relating to a grant program to fund certain railroad grade separation projects. Signed by Governor Abbott on May 24, 2025.
- SB 1729, Relating to the registration and inspection of vehicles. Signed by Governor Abbott on May 24, 2025.
- SB 1841, Relating to the confidentiality of certain information collected by certain local governments and airport governing boards. Signed by Governor Abbott on May 24, 2025.
- SB 2351, Relating to the construction, expansion, or modification of certain concrete plants under a standard permit. Signed by Governor Abbott on May 24, 2025.
- HB 4520, Relating to requirements for loans or grants provided by the Texas Transportation Commission to aviation facilities located in economically disadvantaged counties. Passed in the Senate on May 26, 2025. Enrolled and forwarded to the governor for action.
- HB 1109, Relating to an exemption from certain motor fuel taxes for counties in this state. Signed by Governor Abbott on May 26, 2025.
- HB 2011, Relating to the right to repurchase from a condemning entity certain real property for which ad valorem taxes are delinquent. The House refused to concur in Senate amendments on May 27, 2025. The conferences are Bell of Montgomery (Chair), Hinojosa, Hunter, Kitzman and Lalani.
- SB 15, Relating to size and density requirements for residential lots in certain municipalities; authorizing a fee. Passed to third reading in the House on May 27, 2025.

- SB 546, Relating to seat belts on buses that transport children. Passed the House on May 27, 2025. Enrolled and forwarded to the governor for action.
- SB 826, Relating to the operation of a motor vehicle in a school crossing zone while intoxicated. Passed to third reading in the House on May 27, 2025.
- SB 2321, Relating to the regulation of emissions by the Texas Commission on Environmental Quality during an event affecting electric demand or grid reliability. Passed to third reading in the House on May 27, 2025.
- HB 500, Relating to making supplemental appropriations and reductions in appropriations and giving direction and adjustment authority regarding appropriations. Passed the Senate on May 27, 2025. Enrolled and forwarded to the governor for action.
- HB 2078, Relating to the joint planning of desired future conditions in groundwater management areas. Passed the Senate on May 27, 2025. Enrolled and forwarded to the governor for action.
- HJR 7, Proposing a constitutional amendment to dedicate a portion of the revenue derived from state sales and use taxes to the Texas water fund. Passed the Senate on May 27, 2025. Enrolled and forwarded to the governor for action.
- HB 5033, Relating to elimination of the motor vehicle emissions inspection and maintenance program. House concurred in Senate amendments on May 28, 2025.
- SB 7, Relating to the oversight and financing of certain water infrastructure matters under the jurisdiction of the Texas Water Development Board. Passed the House on May 28, 2025, and set on Senate Items Eligible Calendar.
- SB 15, Relating to size and density requirements for residential lots in certain municipalities; authorizing a fee. Passed the House on May 28, 2025, and set on Senate Items Eligible Calendar.
- SB 763, Relating to the renewal and review of standard permits for certain concrete plants. Passed the House on May 28, 2025, and set on Senate Items Eligible Calendar.
- SB 826, Relating to the operation of a motor vehicle in a school crossing zone while intoxicated. Passed the House on May 28, 2025, and set on Senate Items Eligible Calendar.
- SB 2321, Relating to the regulation of emissions by the Texas Commission on Environmental Quality during an event affecting electric demand or grid reliability. Passed the House on May 28, 2025, and set on Senate Items Eligible Calendar.
- SB 480, Relating to the authority of a local government to enter into an interlocal contract with certain governmental entities to participate in water research or planning activities. Signed by the governor on May 28, 2025.
- SB 2039, Relating to the applicability of certain pedestrian laws to certain sidewalk users. Filed without signature by governor on May 28, 2025.
