## 2.2. Endorsement of Transit Strategic Partnerships Program: May 2024 Cycle Selected Project

Presenter: Dora Kelly, NCTCOG

Item Summary: Staff is seeking endorsement of the project evaluated through the May 2024 Cycle of Transit Strategic Partnerships Program to provide funding to Feonix Mobility Rising for the pilot of a Transportation Assistance Hub in portions of Dallas and Ellis counties.

Background: In the May 2024 cycle, one project was reviewed as a carryover from the previous November 2023 cycle. It was presented to the Surface Transportation Technical Committee in September. Feonix Mobility Rising is proposing to address transit needs by using mobility navigators to connect riders with existing services and offer access to a volunteer driver program for mobility impaired residents and seniors where no other service is available or accessible. The selected project aligns with regional goals set forth in 2022 Access North Texas, the regional public transportation coordination plan for the 16county North Central Texas area, which documents the transportation needs of older adults, individuals with disabilities, and individuals with lower incomes across the region. As part of the Transit Strategic Partnerships Program, staff requested Regional Transportation Council approval on October 17, 2024, for Federal Transit Administration (FTA) funding under Section 5310 Enhanced Mobility for Seniors and Individuals with Disabilities in an amount not to exceed \$475,000 in federal funding. ## 2.3. Strategic Highway Network Route Proposed Additions

	Transportation Council (RTC) approval to add a roadway
	location within the Dallas-Fort Worth region to the
	Strategic Roadway Network (STRAHNET).
Background:	STRAHNET, a subset of the National Highway System
	(NHS), is a network of highways, including the Interstate
	System, that provide connecting routes to military
	installations, industries, and resources in times of peace
	and war. The Texas Department of Transportation

(TxDOT) and the Department of Defense (DOD) have been coordinating the addition of existing roadway locations to STRAHNET as part of the DOD's efforts to improve connectivity between Fort Bliss and Fort Cavazos and their designated seaports of embarkation in Port Beaumont and Port Arthur. As a result of this effort, a roadway location within the Dallas-Fort Worth region has been selected as a proposed addition to STRAHNET. A map and table detailing the proposed addition is included in Electronic Item 2.3.

## 2.4. Blue-Green-Grey Application for New Ideas Round 4 – Project Funding Recommendations

Presenter: Shawn Conrad, NCTCOG Item Summary: Staff will request approval of the Blue-Green-Grey application recommended for funding. The North Central Texas Council of Governments Background: (NCTCOG) issued the Round 4 Blue-Green-Grey funding opportunity on July 15, 2024. Applications were due on August 16, 2024. Eligible projects are within the 12county Metropolitan Planning Area and incorporate three elements – Blue (water), Green (environment), and Grey (transportation infrastructure). The goal of the Blue-Green-Grey program is to support innovative pilot projects that provide resources for cities and organizations to replicate these ideas throughout the metroplex. The total of available funds is \$250,000 RTC Local. A project evaluation committee reviewed the nine applications received and is recommending three projects for a total funding recommendation of \$248,200 RTC Local. The recommended projects were presented at the September 27, 2024, Surface Transportation Technical Committee meeting as information as well as the Transportation Public Meeting on October 15, 2024. 		Background:	Regional Transportation Council for local match funds. The United States Department of Defense has announced a Notice of Funding Opportunity for the Community Noise Mitigation Program. This program is intended to assist local governments impacted by military fixed-wing aviation noise through the installation of noise mitigating insulation at covered facilities, with specific funding set aside for reserve bases that have transitioned to a new type or model of aircraft. The Naval Air Station Joint Reserve Base Fort Worth (NAS JRB Fort Worth) is in the process of transitioning from F-16 to F-35 aircraft. Staff will provide an overview of the proposed grants to be submitted by the North Central Texas Council of Governments. Total project cost is approximately \$4 million. The grant application will request 90 percent of the cost in federal funds, supported by a local match of Regional Transportation Council (RTC) Local funds and an equivalent amount provided by two participating school districts – Lake Worth and White Settlement Independent School Districts (ISD) – for the required 10 percent local match. If awarded, the grant applications will include noise insulation construction in six facilities in these two ISDs. These facilities include schools that are experiencing high levels of indoor noise as a result of military aviation operations. RTC Local funds previously approved by the RTC as part of the Regional Joint Land Use Study, has been used for upfront costs that will cover 5 percent of the match. The Lake Worth and White Settlement ISDs will pay the remaining 5 percent portion of the local match. Staff will request Committee action to backfill RTC Local funding for the Regional Joint Land Use Study. An overview of the proposed project is included in Electronic Item 3.

	signal equipment. RTC has allocated funding to begin				
	upgrading signals that fall below these standards. To				
	maximize the impact of this funding, staff is proposing a				
	strategic selection process based on the regional inventory to				
	prioritize locations for upgrades. While the inventory identified				
	numerous signals requiring equipment improvements, the				
	available funds will not cover all necessary upgrades.

named CERTT). This program serves to guide a con					
	building path among	the RTC, interested lo	ocal governments,		

and transportation technology providers in bringing innovative transportation solutions to our region with the end goal of a commercial application serving a long-range transportation need. Swyft Cities advanced through Round 2 of the CERTT Program in spring 2023 and received several proposals from interested local governments. Since that point, Swyft Cities has been engaged with the North Central Texas Council of Governments (NCTCOG) and interested local governments in advancing potential project locations, determining appropriate technology certification oversight structures, considering public-private partnerships, balancing roles and shared risk, and developing a potential funding package for initial deployment. Recently, NCTCOG submitted a letter of commitment to the United States Department of Transportation supporting the City of Arlington's "Improving Access, Safety, and the Environment with Aerial Automated Transit Networks" grant application and their request for the 2024 Strengthening Mobility and Revolutionizing Transportation (SMART) grant submittal.
