1. Welcome and Introductions.

Subcommittee Chair, Ranjan Muttiah, led the welcome and introductions.

2. Approval of the July 11, 2018 Meeting Summary.

The meeting summary was approved with no changes.

3. Special Update. Special update from the USACE on NOAA Atlas 14 Volume 11 updated rainfall precipitation frequency estimates for Texas.

Mikaela Mahoney and Max Strickler, USACE, gave a presentation about NOAA Atlas 14 Volume 11 methodology and results for the North Central Texas region. The new precipitation estimates show an increase in precipitation for the region, but as a whole, the increases are not as dramatic as in Central or Southeast Texas. The speakers gave instructions on how to access the data for use by communities.

4. Regulatory Update. The North Central Texas Council of Governments (NCTCOG) staff will provide an update on regulatory developments.

Mia Brown informed the Subcommittee that there have been no new developments regarding the renewal of the Small Phase II MS4 General Permit, and that cities should continue to operate under their current permit after the December 13, 2018, expiration date. Mia also provided a follow-up on Senate Bill 3303 (Water Quality Certification Improvement Act of 2018), which has not seen movement since a hearing was held in the Committee of Public Works and the Environment on August 16, 2018.

Mia Brown gave the Subcommittee the following updates:

- New Inspectors Training was held in Flower Mound on November 6.
- Due to demand, there are plans to hold another Construction Contracts Training in the near future.
- The next PWC meeting is scheduled for November 29th at 9:30 a.m., NCTCOG Offices
- The SPROW Subcommittee will be focusing on Small Cell Implementation and its impact on local governments. Their next meeting will be held Tuesday January 22 at NCTCOG Offices.
- The Standard Drawings Subcommittee is currently wrapping up edits to the Division 1000: Erosion & Sediment Control Drawings from the Fifth Edition of the Public Works Construction Standards. Next, the Subcommittee will be focusing on Division 6000: Stormwater Drainage. Their next meeting will be held Monday December 17 at NCTCOG Offices.

6. **Work Scope.** Discuss Task Order projects with consultants, Halff Associates, Inc.
- a. Consider replacement of Figure 3.5 in Task Order 2 with another drawing, due to a recommendation by the Standard Drawings Subcommittee.

The Subcommittee decided that Figure 3.30 (Schematics of Excavated Stone Outlet Sediment Trap) would be a suitable replacement for Figure 3.5 in Task Order 2.

- b. Task Order 2 project update.

Ben Pylant, Halff Associates, gave the following update:

- The draft of the ten site development controls selected will be 80% complete and ready for review in January or February.
- A summary of the findings draft for recommended specifications and minimum achievements for a proprietary device will be available in January.
- Halff Associates will co-host a workshop and summary of findings on December 4th.

7. Roundtable Discussion.

NCTCOG staff gave the following updates:

- The Stormwater BMP Workshop will be held December 4th, 2018, from 8:30 a.m. to 12:00 p.m. at the AgriLife Research and Extension Center on Coit Road.
- The Environment and Development Department is working with the Transportation Department on a proposal for a comprehensive planning initiative that combines stormwater with the next Mobility Plan. The USACE is planning to be a technical partner if NCTCOG raises \$10 million, of which half has been raised. The study would model drainage basins for proposed roadways and look at incorporation of different types of detention measures.
- Please think about items for the next task order, which will be discussed at the next iSWM Subcommittee meeting.
- The Standard Drawing Subcommittee is looking at Division 6000 (Stormwater Drainage) next and are looking for stormwater experts. If you would like to participate, please let NCTCOG staff know.
